

Home Health Visits for New Moms

Michigan Medicine through Michigan Visiting Nurses (MVN) has offered an early discharge program since the mid-1990s for mothers and their babies. An experienced mother and baby registered nurse (RN) will make a visit to your home 2 to 7 days following discharge.

Q. What will the RN do?

For Mom: The RN will offer a complete post-partum (after pregnancy) assessment in your home which many women find helpful because post-partum office visits are scheduled 4-6 weeks following delivery. The RN will reinforce information you receive at the hospital and answer questions that you have had at home since discharge.

For Baby: The RN will complete an assessment of your baby's health including weighing the baby, vital signs, and a check for jaundice. This may save an extra trip to the pediatrician if there are weight loss and jaundice issues. The RN will provide expert assistance for breastfeeding which many women find extremely helpful. The RN will also review education with you on feeding, sleeping, normal development, and signs of illness.

Q. What are the benefits?

The RN will reinforce the information you received in the hospital. Families have commented that they are grateful to receive the extra support so soon after leaving the hospital. RNs identify clinical and education needs during the home visit that require follow up with your pediatrician or OB provider. Since Michigan Visiting Nurses (MVN) is a part of Michigan Medicine, the RN documents the visit in your electronic health record (MiChart) so it is accessible to you and your baby's provider for their review.

Q. How is the visit arranged?

After you are discharged, the MVN program coordinator will call you to verify your address and phone number and let you know the RN will be calling to schedule your visit time if the following criteria apply:

- ✓ You went home 24 hours after a vaginal birth or 48 hours after a cesarean birth
- ✓ You live within the MVN service territory (All of Washtenaw County and areas of Livingston, Wayne, Jackson, Lenawee, Monroe and Oakland).

Q. Will my home visit be paid by insurance?

Medicaid and most Blue Cross/Blue Shield and Blue Care Network plans cover this visit. However, you may owe for a deductible, coinsurance or copay. If you are covered under a different insurance company, have no insurance or have questions about what your out-of-pocket cost will be, please call Michigan Medicine Patient Business Services at (877) 326 – 9155 Monday- Friday, 8:00am-8:00pm.

Q. What if I have more questions about the home visit?
