Transportation assistance

There are two types of transportation assistance – mileage reimbursement and medical transportation to and from appointments.

If your child has regular (straight) Medicaid:

And you live in **Wayne, Oakland and Macomb** counties:

- You are eligible for mileage reimbursement or medical transportation. To arrange, please contact ModivCare at: (866) 569-1908.

For all **other** counties in Michigan:

- You are eligible for mileage reimbursement. The mileage reimbursement form must be brought to the appointment and signed by the doctor or nurse. Some counties also provide medical transportation. Please contact your Department of Health and Human Services (DHHS) worker for a medical transportation form and to ask if your county has medical transportation.

If your child has a Medicaid HMO:

- Most of the Medicaid managed care programs provide transportation to and from medical appointments. Some also provide mileage reimbursement. Please contact them directly to find out how to arrange transportation or get reimbursement for gas. The phone number will be on the back of your child's insurance card.

If your child is on Children's Special Health Care Services (CSHCS):

If your child has straight Medicaid as well as CSHCS:

- Please see previous section regarding reimbursement through straight Medicaid.

If your child is enrolled in CSHCS (and not Medicaid):

- There is both a mileage reimbursement and medical transportation benefit. Please contact your local office to discuss mileage reimbursement or arranging a ride to an appointment.

- If you do not have the phone number to your local CHSCS office, please call the Family Help Line at (800)359-3722.

Other options for transportation assistance:

The Michigan Medicine Department of Social Work has limited assistance for families that meet certain guidelines and do not have immediate access to mileage reimbursement through any state insurance program. Please contact the Guest Assistance Program at 734-764-6893 for information and assistance.

Lodging information

There are a number of places that moms, dads, guardians, family, and friends can stay overnight in and around the hospital. Please note that not all options are appropriate for children or adults with special needs.

Lodging in the hospital:

In the Pediatric Intensive Care Unit (PICU) and the Neonatal Intensive Care Unit (NICU):

- 1 parent/guardian can sleep at the bedside at night. Other adult visitors are permitted to stay in the nearby family waiting rooms. Please keep in mind that the waiting rooms are not private, and they do not have beds. They are not the most comfortable accommodations, but if you want to be as close to your child at night as possible while they are cared for in the PICU, then the waiting rooms are the place to stay.

If your child is admitted to the Pediatric Ventilator Unit (PVU) on 12W:

- 2 adults, over the age of 18, may sleep at bedside. Visitors are not allowed to sleep overnight in the waiting rooms on the general care floors. Visitors **under the age of 18** are allowed to stay **until 9 p.m.**, at which time they will need to leave for the night.

Med Inn Hotel

Limited accommodations are available at the Med Inn which is a 30-room hotel that is part of the hospital complex. The Med Inn is available for the families of both pediatric and adult patients. While preference is given to those families whose loved one is in an intensive care unit, it can still be very difficult to get a room. The Med Inn costs \$75 a night for one queen bed, \$80 a night for two queen beds and they **do not accept Medicaid or Children's Special Health Care Services (CSHCS)**. Please note: In the event that the Med Inn does not have a vacancy, the staff in the Patient and Visitor Accommodations Program can make a reservation for you at another contracted offsite hotel in Ann Arbor.

- You can contact staff in the Guest Assistance Program at (734) 764-6893 or go to their office on the second floor of University Hospital near the cafeteria between 9:00 a.m. and 5:00 p.m. Monday through Friday.

Ronald McDonald House (RMH)

RMH is close to Mott on Washington Heights Street, and it is about a 5-minute walk to the hospital. The Ronald McDonald House is considered communal living which means that you and your family would have your own bedroom, but you would likely share a bathroom, a kitchen, and living area with other families whose children are staying with us in C.S. Mott Children's Hospital. You will also have a daily chore.

- The Ronald McDonald House costs \$10 a night, and rooms are reserved on a first-come, first-served basis.
- Up to four family members can stay in the Ronald McDonald House, including children.

- The Ronald McDonald House is a popular place to stay for many families, so if you think you might want to stay there, you should call to see if they have any rooms available. If they do not have any rooms when you call, you can ask them to put your name on the waitlist for a room.
- There is also a 10-room Ronald McDonald House within C.S. Mott Children's Hospital. Only 2 visitors age 18 and older are able to stay in these rooms. The rooms in the "Mott House" are reserved for families whose children are in the ICU, and are intended for brief, 1-2 night stays.
- **You can inquire about room availability at the Ronald McDonald House by calling (734) 994-4442.**

Ann Arbor lodging:

- For hotels and extended stay facilities (with kitchen facilities) in Ann Arbor that have **reduced rates** for UMHS patients and their families, or hotels in Ann Arbor that will **bill Medicaid or CSHCS directly**, please contact the UMHS Patient and Visitor Accommodations to make arrangements at (800) 544-8684 or (734) 936-0135.
- There are other hotels and motels around the city of Ann Arbor. Some are a few miles from the hospital and can be reached by car, taxi, bus, and hotel shuttle, depending on the hotel or motel. Please request a list of hotels by contacting the Patient and Visitor Accommodations Program at: (800) 544-8684 or (734) 936-0135, or visit their Web site at www.med.umich.edu/hotels

Local hotel shuttle transportation

Some local hotels offer free shuttles between their facilities and the hospital. The hours of operation are typically limited to daytime hours and may not run at all on the weekend. Please check with your hotel or with Patient and Visitor Accommodations (1-800-544-8684 or 734-936-0135) staff to identify the hotels with this service. In addition, Michigan Medicine Department of Social Work

has limited assistance for families that meet certain guidelines and do not have immediate access to transportation assistance programs through insurance or community agencies.

Lodging and meals assistance

If your child has regular (straight) Medicaid:

If your child has straight Medicaid, and you live in **Wayne, Oakland and Macomb** counties, and you live **more than 50 miles** away from Mott:

- You are eligible for lodging and meal assistance. To arrange lodging and meal benefits through ModivCare, a form must be signed by the doctor and submitted to ModivCare. Please contact the Pediatric Home Ventilator Program Social Worker to get help with this.

For all **other** counties in Michigan who live **more than 50 miles** away from the hospital:

- Lodging and meal benefits are available through the Department of Health and Human Services (DHHS). Please contact the Pediatric Home Ventilator Program Social Worker to assist with this process.

If your child has a Medicaid HMO:

- Some Medicaid HMO's have meal and lodging benefits. Most have specific eligibility requirements. Please call the insurance company directly or the Pediatric Home Ventilator Program Social Worker to find out if you qualify for benefits.

If your child is on Children's Special Health Care Services (CSHCS):

- If your child has Medicaid as well as CSHCS, please see previous section regarding reimbursement through straight Medicaid.
- If your child is enrolled in CSHCS (and not Medicaid), there is a lodging benefit. There is **no** meal benefit.

- Please contact the Michigan Medicine Patient and Visitor Accommodation at (800) 544-8684 or (734) 936-0135 or the Pediatric Home Ventilator Program Social Worker to make a hotel reservation.
- The Guest Assistance Program can contact your local CSHCS office to obtain a lodging authorization for the hotel stay.

Other options for lodging assistance:

- The Michigan Medicine Department of Social Work has limited assistance for families that meet certain guidelines and do not have immediate access to lodging and meal benefits through any state insurance program.

Income Programs

There are government programs that provide income to children based upon their level of disability and parent income.

Supplemental Security Income (SSI)

Supplemental Security Income (SSI) is a program of the Social Security Administration. This is a program through the Federal Government and is available in every state. SSI provides need-based income for people who meet the requirements.

- Your child must be either blind or disabled.
- Your child may be eligible beginning as early as the date of birth.
- Your child may be eligible until age 18.
 - When your child turns age 18, impairments are evaluated based on the definition of disability for adults.
- A child with a visual impairment may be eligible if the impairment meets the definition of blindness below.

What are the additional requirements for a disabled or blind child?

- If under 18, your child must have a medically determined **physical** or **mental** disability which result in obvious and severe functional limitations.
- The condition(s) must have lasted or be expected to last for a continuous period of at least 12 months or be expected to result in death.
- If your child is blind, they must have a central visual acuity of 20/200 or worse.

What does deeming mean for income eligibility?

- If a child is under age 18, not married, and lives at home with a parent(s) who do not receive SSI benefits, a part of the parents' income and resources is counted.
 - A part of a stepparent's income and resources may also count if your child lives with both a biological or adoptive parent and a stepparent.
- This process is called "**deeming**." Deductions are made from deemed income for parents and for other children living in the home. After the deductions are subtracted, the remaining amount is used to decide if your child meets the SSI income and resource requirements for a monthly benefit.

Where can I learn more?

To find out more information or to apply for SSI on behalf of your child, please contact the Social Security Administration at 1(800) 772-1213 or visit their website at www.socialsecurity.gov. The Pediatric Home Ventilator Program Social Worker is available to assist you with questions regarding this program.

State Disability Assistance (SDA)

The SDA program provides cash assistance to people who are disabled for at least 90 days. Your child may be considered disabled for purposes of SDA if they are:

- Attending school and approved for special education services
- Approved for disability-based Medicaid

- Living in a substance abuse treatment center, adult foster care, home for the aged, or county hospital
- Diagnosed with AIDS
- An active Michigan Rehabilitation Services (MRS) client
- A person with disability that meets Social Security's definition of disability (even if not expected to last 12 months)
- A refugee or asylee that has been cut off of SSI because of time limits

SDA provides cash assistance of up to \$264 per month. If you have income, the SDA payment will be reduced. Different rates apply to couples and people in special living arrangements.

What are Repay Agreements?

People often apply for SDA to help make ends meet while their application for SSI (Social Security) is pending. In these cases, you are required to sign a paper called a **repay agreement**. This allows the Michigan Department of Human Services to keep any SSI necessary to pay itself back for any SDA you received while your SSI application was pending.

What are Asset Limits for receiving SDA?

DHS recently changed its policy regarding how and when it calculates your assets (the value of things you own) for purposes of SDA. You are now eligible for SDA if your assets drop below \$3000 at any time in the month of your application.

Family Support Subsidy (FSS)

The FSS is available in Michigan for families with less than \$60,000 annual income and who have a child under age 18 whose school has determined them to have:

- Cognitive impairment (CI)
- Severe multiple impairment (SXI) or
- Autism spectrum disorder

Children with CI must be in the severe range of functioning as decided by the local or intermediate school district. Children with autism must be receiving special education services in a program designed for students with autism, severe cognitive impairment or severe multiple impairments. Many children with severe disabilities cannot eat, walk, dress, or talk on their own. They often have both mental and physical impairments and need round-the-clock care. Families with children with severe disabilities have many expenses other families do not.

The Family Support Subsidy might be useful for the purchase of items needed to care for your child. Items include: special equipment, special foods, diapers, transportation costs, in-home care, respite care, family counseling, general household expenses, family recreation, and home remodeling to provide for special needs. Families can be headed by birth parents, adoptive parents, or legal guardians. Foster parents are not eligible.

How can I apply for FSS?

You can get an application for FSS at your local office of Michigan's Community Mental Health Services Program (CMHSP). Your local CMHSP determines eligibility for this subsidy program. CMHSPs are listed in most telephone books and online at: <http://www.michigan.gov/mdch/>

If your child is enrolled in either Early On or Children's Special Health Care Services (CSHCS), they can also assist with applying for FSS:

Insurance

Medicaid

Medicaid is health insurance available to people who are aged, blind, or disabled. There are income and asset limits. If your income is over the Medicaid limit, you may still be able to get help with your medical bills through a Medicaid **spend-down program**. The amount your income is over the Medicaid limit is called **excess income**. If you have medical expenses that equal or exceed the excess income you may still qualify to have your medical bills paid for.

- If your child is already on Medicaid, you will have to reapply when they turn 18 years old.
- If your child is not on Medicaid, they may be eligible at 18 years of age as the government considers only their income when they become a legal adult.

A person can have private insurance and still be eligible for Medicaid. Young adults can remain on their parents' insurance until the age of 26. However, it may be beneficial to have Medicaid as a secondary insurance to pay medical

costs not covered by the primary insurance, such as co-pays, diaper supplies, etc.

MIChild

Children under age 19 whose family income is too high for Medicaid/Healthy Kids may be able to get health and dental care insurance through MIChild. To qualify, your child must:

- Be under age 19
- Have no comprehensive health insurance, including Medicaid
- Have a Social Security Number (or have applied for one)
- Live in Michigan, even for a short time
- Be a U.S. citizen or qualified immigrant
- Meet monthly family income limits

How much does MIChild cost?

There is a low monthly cost for your whole family (even if you have more than one child).

How do I apply for MIChild?

Children's Special Health Care Services (CSHCS)

CSHCS is a program that pays for the medical care of children with certain chronic illnesses.

- Children must have a qualifying medical condition and be less than 21 years old to be eligible.
 - People 21 and over with cystic fibrosis or certain blood clotting disorders may also qualify for services.
- This program is for both uninsured and insured patients. It also provides supportive programs for parents.
- The goal of the CSHCS program is to assure that children with chronic medical conditions have access to the specialty care needed.

The child's medical condition, not income, determines eligibility for this program. There may be a monthly premium payment depending on family size and income. The income of young adults between the ages of 18 and 21 are considered separate from their parents.

What are the Benefits of CSHCS?

CSHCS works with you to ensure the very best care is received for your child's medical condition. CSHCS helps with:

- Paying specialty medical bills
- Coordinating services from multiple providers
- Covering co-pays or deductibles
- In some cases, CSHCS can cover other insurance premiums

How does someone enroll in CSHCS?

Two forms are needed for enrollment to be completed:

- **Medical Eligibility Report Form (MERF):** Your child's specialty physician must submit the MERF to the State. At Michigan Medicine, the Pediatric Home Ventilator Program Social Worker will help with this.

- Patient/Parent application: The parent or young adult over 18 will receive an application in the mail if the child is accepted into the program. Completed applications must be sent back to the main CHSCS in Lansing, MI.
 - If your child has Medicaid coverage, the patient/parent application is not required to initiate the coverage.

Caretaker Relative Medicaid

Medicaid is available to eligible parents and people who act as parents, caring for a dependent disabled child. These people are called caretaker relatives. There is an income limit for this program.

If your income is over the income limit, you may still be able to get help with your medical bills through a Medicaid **spend-down program**. The amount your income is over the Medicaid limit is called **excess income**. If you have medical expenses that equal or exceed your excess income then through this program, your medical expenses that equal or exceed the excess income are paid for. Contact the local DHS in your county to apply for this program. The DHS will need a form (DHS Form 54A - Medical Needs Form) completed by your child's doctor to state that you are needed in the home to care for the child.

TEFRA Medicaid

The Tax Equity and Fiscal Responsibility Act (TEFRA) Medicaid Eligibility Option allows children with disabilities from near-poor and middle-income families to qualify for Medicaid. Through TEFRA, children can receive Medicaid services that address their needs, but still live with their families.

What is not covered by most insurance?

While you might have adequate health insurance coverage for your child, there may be services your insurance will not cover, such as:

- Private Duty Nursing (PDN) services to assist with 24/7 care needs in the home environment
- Transportation to and from the hospital for frequent clinic visits
- Temporary lodging and meals for family members
- Parking fees for visits to the hospital
- Insurance premiums, co-pays, and deductible amounts

Changes in coverage:

While planning ahead, there are some important things to consider that may change with your child's insurance coverage:

- Reaching the maximum limit the insurance company will pay per year or over a lifetime.
- Divorce or separation from a spouse can lead to cancellation of coverage on the spouse's policy.
- Changes that may impact the insurance coverage, including a change in job status due to health, lay-off, change in student status, or other causes.
- Changes in your child's insurance policy that can lead to increased co-pays or deductibles.
- Children becoming adults and no longer being covered under their parents' insurance or state-funded health plans.

UMHS Patient Financial Counseling

The Patient Financial Counseling team provides individual patient financial counseling related to both hospital and professional services. They assist those who need to apply for state, county and UMHS alternative funding programs, as well as respond to your insurance benefit questions, generate charge estimates and assist with making payment plans.

Other helpful information

Work or school letters

Many times your employer or your child's school will require a note to verify the clinic visit or hospital stay. Please inform the Pediatric Home Ventilator Program team before leaving the clinic area or discharge home, so we can provide you with one.

Disability or other forms

Disability and other forms required by DHHS or Medicaid can be completed by the Pediatric Home Ventilator Program team. Please provide them to the Social Worker and they will coordinate completion and provide them to you via email, the patient portal or in person at your next scheduled clinic appointment.

FMLA (Family Medical Leave Act)

If you must take time away from work to care for your child, ask your employer if you are eligible for FMLA. Your social worker can assist you with paperwork for this as needed.

Vacation travel

In preparation for traveling far from home, please contact the Pediatric Home Ventilator Program nurse to discuss tips and documentation required to pass through Transportation and Security Administration (TSA) at the airport.
