The Frankel Cardiovascular Center (FCVC) Advance Practice Provider Postgraduate Critical Care Fellowship is designed to provide advanced training in critical care for APPs. The FCVC is at the forefront of innovative, advanced surgical procedures and cutting-edge research. The CVICU admits patients from multiple surgical service lines and has an estimated case volume of over 1800 complex cardiac surgical cases per year.

Efforts to combat the magnitude of cardiovascular disease through our tri-partite mission: clinical care, research, and education are ongoing. We're doing it with expert multi-disciplinary medical teams, researchers, and educators as we strive to continually advance our efforts to become the "best academic heart and vascular center in the world".

The Critical Care Fellowship offers a paid 12-month clinical and didactic program. - A one-page personal statement of your career goals and objectives that specifies a) why you want to be the Frankel Cardiovascular Center Critical Care Fellow; b) how you think the Frankel Cardiovascular Center APP Critical Care Fellowship will develop you personally and professionally to pursue your short and long-term goals; and c) how your previous experiences (academic and/or professional) have influenced your envisioned contribution to the FCVC APP Postgraduate Critical Care Fellowship.

3. Letters of Recommendation (3)

- For recent graduates or current students, 1 must be from Program Faculty. (If not a recent graduate, 1 letter must be from current or recent employer.)
- Official PA/NP Program Transcripts
- Please address letters of recommendation to 'Frankel Cardiovascular Center APP Postgraduate Critical Care Fellowship Selection Committee'.
